Public Comment

Dr. Ed Williams. The Board of Directors cannot institute a sales tax without a referendum. Please make sure you are familiar with the Georgia Constitution. The Board cannot continue to pass amendments for a contract that was only meant to be 50 years.

Ms. Amanda Chapman. MARTA is as good as its employees. MARTA needs to revamp its Human Resources department. There is too much favoritism. The Decatur station elevator has been out since May. The elevator is down more than it is up. Please repair the elevator.

Ms. Joetta Burnette. I was hurt. I have been asking for help. I hope before the day is over I receive help.

Mr. Alan Babilinski. The MARTA app does not always work. With everything going on around the Beltline, we lack connectivity. He asked that the Board reconsider some of the routes to bring connectivity to the Beltline.

Ms. Tenel Belcher. There are station agents and station maintainers that witness violent acts at MARTA stations. When police officers encounter a shooting, they are immediately put on administrative leave so that they can decompress; so are workers in other professions such as teachers/students, firemen. Ms. Belcher asked that the Board consider putting MARTA employees that experience violent acts on leave in order to decompress.

Ms. Gina Mangham. The community is open to light rail. The community is not set on heavy rail. We need to move to the next step. Ms. Mangham asked that the MARTA Board look at the budget in order to invest in a study and planning for rail for southeast DeKalb.

Mr. Marcellus Rowe. A MARTA employee and taxpayer. MARTA's managerial team is ignoring the low morale of both represented and non-represented employees. Employees are being mistreated and belittled when filing complaints.

Ms. Sherry Williams. Expressed enjoyment of today's Work Session on TOD and looks forward to future plans especially for south of I-20, S. Fulton and Clayton. Affordable housing numbers look promising. Please include Georgia Stand Up in future planning.

Additionally, both escalators were out at Oakland City today. The timespan to repair escalators and elevators needs attention. It takes too long for repair. Ms. Williams urged everyone to wear pink next month in observance of National Breast Cancer month.

Mr. Paul Jones. The three Atlanta Board members, the three Fulton County Board members and the four DeKalb County Board members: I cease to be amazed, MARTA continually deciding not to put the adopted budget on MARTA's website, particularly the Capital Budget. Residents of DeKalb continue to request expanded rail. Gwinnett cannot connect with rail without coming through DeKalb. Why does Gwinnet want to be a part of MARTA? Why can't the Budget go online before October/November? The jurisdictional reports are different for each jurisdiction, particularly when it comes to the MORE MARTA program. MARTA is taking DeKalb money to take care of Atlanta. To the three Atlanta Board members – I cannot find out how much the streetcar extension will cost. Will it be double or single track?
